### THE THEMES

- THE INCREASING DEATH RATE (Jan-Oct 2008 185 attacks in 29 countries; EU 498 attacks in 2006; 1970s 4.47; 2000/03 14.49; target 4,000,000; WMD & FMUF).
- THE EVOLUTION OF STATES' COUNTER-TERRORISM RESPONSES ("steep learning curve").
- POLITICAL STRUGGLE; POLITICAL DYNAMICS.
- THE PRIMACY OF PARLIAMENT.

#### THE KEY ROLE OF PRISONS

#### **THREATS**

- Security of people committed to murder
- Leakage of terror into the prison system (HMPs Belmarsh; Whitemoor, Franklands – planned beheading of a PO)
- Forced conversions
- Threats to staff (IRA killed 29 POs; Italy, Spain); prisoners.
- Staff compromised
- Threats to staff from visitors
- Refusal to engage in programs
- Site for martyrdom, displays of narcissism
- Disruption of wider counter-terrorism effort
- Radicalisation

Australia: Since 2002, 29 charged; a dozen cells, 60 individuals

- ITALY separate high security prisons
- SPAIN concentration then dispersal (Canary Is 4000kms)
- NORTHERN IRELAND HMPs Maze, Maghaberry
- Separate terrorist prisoners from others
- Within terrorists, isolate the extremists from colleagues
- Cornell Uni (2007) mathematical modellingdiversity/radicalisation
- Internal dispersal (new Saudi Arabian prisons)
- Frequent movement
- RFID

deny the role of criminal justice system/policing nevertheless, globally it is a war

#### RADICALISATION

- DECLINE OF RADICAL IMAMS IN THE COMMUNITY-The prison to terrorism path; internet recruitment
- RADICALISATION 2005, 175 cases in France; US vetting of Imams; forced conversions etc in UK
- NSW Conversion? of Indigenous prisoners (Bassam Hamzy)
- De-programming (Saudi Arabia, Singapore, Malaysia, Yemen, Egypt, UK – Extremism Unit, Imams)

# al-Qaeda's advice – Abu Yahya al-Libi 9/2007

- Weaken al-Qaeda's ideological appeal e.g. Dr Sayyid Imam Sharif, Salman al-Oadah
- Propaganda e.g. Ayman al-Zawahiri's racist attack on Barak
  Obama (tradition of racism directed at black Africans Dhafur)
- Highlight attacks on people, not property
- Fatwas of mainstream Muslim clerics e.g. Darul Uloom Deobandi 2008, Islamic Council of Spain 2005
- Use of language
- Committees of scholars to de-program terrorists e.g. Saudi Arabia
- Strengthen moderate Muslim movements
- Highlight/exaggerate disputes e.g. clashes between Mullah Omar & Pashtun leader Siirrajudin Haqqani 2008

#### OTHER CORRECTIONAL ISSUES

- IF MENTALLY ILL ARE VULNERABLE, THEN DIVERT
- IF DISCONNECTION FROM SOCIETY, DON'T DENY THE VOTE
- EVENTS IN PRISON SHOULD NOT UNDERMINE WIDER ANTI-TERRORISM EFFORT
